A FOLLOW UP TO OUR GARBAGE COLLECTION CONTRACTS

have been bothered by our garbage collection contract article from the spring newsletter, ever since the mailer went out. I have nobody to blame but myself for not explaining things better at the time. My apologies to our office staff, for dealing with all the phone calls, but more importantly to the residents of our Township.

Our previous contract with Waste Management had run its course. That contract was signed in 2018 and was expiring on April 1st of this year. When we went out to bid for a new contract, I was told by Waste Management that we were in for a real eye opener. They were certainly correct with that statement. Their first year bid price was \$113.70 per quarter. Luckily, County Hauling was looking to expand in Washington County and quoted us a first year bid price of \$82.08. After opening bids and discovering that County Hauling had recently been awarded the contract for Cecil Township, I contacted Cecil to find out how things were going. At the time, Cecil Township had very few complaints and were satisfied with their service. Townships have rules to abide by and one of those rules is that we must award contracts to the lowest, responsible bidder. In this case, that was County Hauling.

Here is the comparison break down of the 3 year contracts for both Waste Management and County Hauling. Both Contracts have two (2), one year extensions. (Price per quarter)

	County Hauling	Waste Management
Year I	\$82.08	\$113.70
Year 2	\$88.65	\$122.79
Year 3	\$95.70	\$132.60

For all the residents that called in and complained that what we did was wrong, I hope that you understand now. We switched haulers because we were legally bound to do so.
